FOR POSSIBLE ACTION: Strategic Plan: No update.

FOR DISCUSSION: Administrator Reporting: Chairman Nebeker requested that when Board members need to make a request of the Administrator that they send the request through the Chairman who will direct the Administrator and track responses.

FOR POSSIBLE ACTION: Use of Surplus Microwave for Clark County School District Police Department: Chairman Nebeker announced that he would abstain on this item. Mr. Amell reviewed the Board's discussion on this item from last month's meeting. A motion was made to donate the surplus microwave to the Clark County School District Police Department (CCSDPD) "as is" with CCSDPD assuming all responsibility for the movement and installation. The motion passed 7-0-1.

FOR POSSIBLE ACTION: Operating Rate Increase for Fiscal Year 2015: The Rate Review Committee has recommended the operating fee be increased from \$185 to \$210 per radio on the SNACC system. Board discussion included a need for more detailed information on how the increased rate was determined. Mr. Chase and Mr. Green agreed to develop an executive summary to present to the Board at the next meeting. Action on this item was tabled.
