- 2. Receive the Administrator's Report with the inclusion of the status on the P25 migration upgrade and SNACC Budget Report for the month of September and October 2016. (FOR DISCUSSION):

SNACC Administrators Report

November 16, 2016

P25 and Console Upgrades-

- > Jason and Jose are working to fire radios reprogrammed with all the correct information in them well before the New Year's Eve Event. This is expected to be accomplished in plenty of time, as things are going very smoothly.
- Motorola and Xerox have been working together on an issue with the RTC Consoles. Xerox has a separate dispatch program which runs in conjunction with the MCC7500 consoles. This is not a system affecting issue, but it does cause erroneous alarms on at the SNACC master site.
- McCarran Airport is complete with their transition to P25. All reports that are that radios are working better than they ever have.

Administrative/Technical Items-

- > SNACC welcomes Assistant Chief Robert Horton as the City of Las Vegas Board member.
- > SNACC has been working with our vendor (DP Air) to get the batteries replaced in the UPS at our office location. We are coordinating with them to make sure there are no system outages during this procedure.
- > The OPS/GOV and Technical Working groups, continue to work on Standard Operating Procedures (SOP) development.
- > SNACC continues to work with the National Park Service on SUA II issues. They are continuing to work out issues on the Federal Government end to become current in payments to SNACC.
- Discussions continue with State communications personnel as to the possibility of tying the proposed state system to both the SNACC and the Las Vegas Metropolitan Police Department system. These were very preliminary conversations, as the state has delayed its Request for Proposal (RFP) release until early next year.
- > SNACC has begun billing agencies for rental radios put on the system for special events. These radios are being billed at the rate of thirty (30) dollars per unit, which includes programming, de-programming, and documentation.
- > Louis Carr (Clark County CIO) has retired from the county to move on to other endeavors. A new CIO will be named by the County Manager in the near future.
- > SNACC has been receiving extremely few calls regarding system issues. While this is great news, please let your agencies know to call SNACC with any issues, so they may be addressed as soon as possible.
- Chris Vasquez suggested that Administrator Goss elaborate more on the rental radios fees and that SNACC is not renting radios. Administrator Goss commented that SNACC is not renting radios.
- Dane Mattoon asked Administrator Goss when the state is going to Request for Proposal (RFP) on their system. Administrator Goss was not sure but believes it will be September 2017.

- Dane Mattoon wanted to know when SNACC was going to do the digital switch so that dispatch centers would have to replace their NICE recorders. Chris Vasquez commented until we upgrade to 7.16 we would then have our users change out their recorders.
- Frank Milligan had a question about the salary and overtime in the two budgets. Administrator Goss informed Mr. Milligan that the SEIU and Clark County were going through negotiations over 2 years of pay raises and retroactive pay on overtime that was owed to two hundred employees. One of those payments was to one of our employees and that is why there is a difference.
- Frank Milligan had a question on the budget totals, Teri Brier informed Mr. Milligan that the error was in the formula and that is why there was a corrected copy.
- 3. Nominate and vote on SNACC Replacement of Lou Amell on the Nevada Public Safety Communications Committee for recommendation of appointment by the Governor. (FOR DISCUSSION):
 - A motion was made to nominate Dane Mattoon as the replacement for Lou Amell and recommend him to the Governor; motion passed unanimously.
- 4. Approve the SNACC Budget presentation for fiscal year 2018. (FOR POSSIBLE ACTION):

 - Motion was made to approve; motion passed unanimously.
- 5. For the SNACC Board to develop a working group for the SNACC Strategic Plan and consider changes to the draft of the Strategic Plan. (FOR DISCUSSION/ACTION):

 - Jeff Buchanan stated that he felt it was necessary to have a group review this plan and assist Dave and himself. Frank Milligan suggested James Morwood would be a good fit for the working group. Bill Baltas offered to join the group. Matt Grogan from the City of Las Vegas Combined Communications Center also offered to join the group.

- > All Fire suppression units have been updated with the new program containing the P25 NCORE channels.

- > Las Vegas Detention and Enforcement reported some missing audio issues. Motorola went out and found a bad speaker and also changed out two network services. We have had no complaints since this was completed.

Administrative Items-

- > SNACC welcomes Matt Grogan as the City of Las Vegas Alternate Board member
- Michael Lane has been appointed as the new Clark County CIO.

Technical Items-

- > SNACC had a brief system outage at approximately 5:30am on 12/13/2016. This was due to the replacement of batteries in the main UPS. We did find that the transfer switch is a "break before make" switch. This means that the UPS must be disconnected from the system before switching of UPS back-up. We have since come up with a way to perform battery replacement with no interruption of service. The total down time for this event was approximately 1.5 minutes.
- > The OPS/GOV and Technical Working groups, continue to work on SOP's development, and future site development.

Introduction and Comments - Capt. Dane Mattoon

Welcome comments by Capt. Mattoon were followed by roundtable introduction of all in attendance.

NDOT - Updates on New State Radio System & Crossband Repeaters - James Whalen

Radio system is in development/technical aspects defined/working with attorney on defining format of ROP/anticipate completed in late January 2017.

No change in Repeaters; relocate Fitzpatrick to a new location; status currently between attorneys and administration services people.

DPS - Updates on NCORE, NDIP- Richard Burger

NCORE being used now. South area: met with Metro and SNACC. Dave Goss to prepare list of Dispatch centers in the South; need to get MOUs; Metro and Clark County are committed to NDOT; Direct Dispatch to Dispatch to South completed this morning. Now back to NDIP; console for every Dispatch Internal Project to enable Dispatchers to talk directly (not over the air) and can select the Dispatch to speak to; can be party line if desired. Currently in use. SOP procedures were created on North side and upon request will provide a copy of that SOP to distribute to group DPS, but only as 'guidelines' for DPS to follow and not a dictate. Each Agency needs to adapt to specific needs.

Testing procedures begun, and will go through the counties to test to ensure system is operating and Dispatchers are motivated to monitor regularly. Depends on center's capability for NHP or another county to contact. Phone is still the primary with System as backup.

Per Dave Goss, path to Metro is through Henderson regarding the status of Talking Path between Communications Consoles.

Washoe County Radio System - Shawn Tayler

System is currently out of LIDS and at capacity with 5. Solution of coverage issues for North Town/vehicular is to put into place portable device and place in vehicles in the area to respond. Working with NDOT and NHP.

Installing sites regarding Tesla (I-80 and US50) require two additional sites to provide First Responders. Have sufficient inventory to carry through.

NCORE System Update - Dave Goss

Working well, outage last week with County switch which was rectified today/SNACC power outage. SNACC failed both times when someone was using it. Will be using it on New Year's Eve. SNACC issue was rectified and all is up and working now.

NCORE Notification procedure (e-mail, phone contacts, group notifications)

Keith Aurich will check with Lester Lewis to see where Clark County is on creating this notification process.

Both events take someone to call and advise if system is not working. A more proactive approach is required so users know when it is 'down.' Better monitoring and a more concerted effort is needed; maybe notify before a test and schedule monthly operational tests with use groups on a regular basis. An e-mail system is needed. Keith Aurich will check on status of the e-mail list, and what triggers notification. Testing after an event to ensure it is working is suggested. Need an e-mail from SNACC to Vinnie Puglia.

LVUA Interoperability Agreements Status Update

Most recent Interoperability Agreements are dated 2012 and are out of date. Copies distributed to attendees to enable updates. Get updated information to Vinnie and he will update from information he receives. Language on the 2012 Agreement is good, only contacts and signature page information requires current information.

<u>FirstNET Regional Rep - Lesia Dickson</u>

Lesia Dickson introduced new FirstNET Regional Representative David Faulkner and presented video presentation 'FirstNet State Plans in 100 seconds'

FirstNET is staffing up per Federal Government mandate. David Faulkner is based in Phoenix, handling AZ and NV and currently also CA.

Court case delaying work on NV plan, anticipate a March Court decision and roll out dates then forthcoming. Focus on determining what Nevada's priorities will be: rural areas, Las Vegas area, connectivity with schools, etc. State Plan will be based on consults with areas of the State. Public Safety users, types of devices, etc. State Plan will be web-based/web portals. 90-day timeline to draft the State Plan, if no decision by Governor then Plan Opts In.

For vendors, if there is an existing infrastructure how can those assets be established. May utilize them and assume vendors will be able to offer a product quickly. Some early builder projects in TX can be at the Band 14 in Houston area, outside of that area they pick up a partner, not roaming but with chips. This RFP asking for input. Be innovative. FirstNET will come talk with you. Remember Public Safety fought Congress for this, Public Safety wanted this and now it has been brought to you. The outcome will be from the questionnaires submitted to FirstNET which will be used to build the State Plan; low response received of completed questionnaires. Data collection process will be incorporated into the second round, also. This is a 25-year contract, with dialog needed to be continual, requiring continual input; no data is lost and continual input will only add to its value. FirstNET is not replacing radios, it simply provides another tool for Public Safety use.
