SNACC Business

Dane Mattoon has retired from the Henderson Police Department.

News on a possible move of the SNACC headquarters is tentatively set for next month. The consultant's report is expected to be complete in that time. The CCWRD engineer will let us know as soon as any new information is available.

Boulder City Dispatch, Fire Alarm Office, Henderson Dispatch centers, and Nevada Gaming Board are updated with new recording equipment.

A training/back up dispatch center is presently being installed at the Veterans Memorial High School. Testing and optimization is underway at this time.

The Hoover Dam project has been delayed due to the Federal government shut down. These negotiations will hopefully continue soon.

We have been in discussion with Aviat Microwave about upgrades to the SNACC system. There is a statewide contract with them that we can attach to. We are still waiting on any information as to a SNACC office/site move, to be able to move forward on this project.

Jason is working with a contractor to replace the batteries for the microwaves on Arden Peak.

- Dave Goss Hoover Dam was delayed due to the Federal shutdown.
- Jeff Buchanan What is the plan with Hoover Dam as far as the plans? We have been in negotiation for a long time.
- Dave Goss We will have more updates regarding Hoover Dam in about three weeks. I have been in discussions with J.R. Roach, I should know in three weeks. If we don't get an answer in three weeks he says we will have to wait until 2021.
- Jeff Buchanan Chief Nicholson how would this impact your organization if you did not have communications with the Hoover Dam, what detriment would you and the Boulder City Police Department experience?
- Kevin Nicholson Currently, the coverage in that area has always been poor so the hope is to get
 the site up and have better coverage for anyone working in that area. We work well with them, often
 we have to switch to VHF to have better communications. They have been through a lot of
 transitions out there so I try to do everything I can to impress the importance and there have been
 those changes.
- Chris Vasquez How about Lake Mead dispatch?
- Kevin Nicholson Same, we have to switch to VHF to communicate.
- Chris Vasquez The VHF system is their standard park channels, the things that we support with SNACC are the IOP channels, I guess what we are trying to come up with is a penalty or a consequence. If they can't pay, if we cut them off, what are the ramifications?
- Kevin Nicholson The SNACC interconnection has never worked, so we use VHF.
- Jeff Buchanan They are about how many years past due?
- Dave Goss Four years.
- Jeff Buchanan At some point we will have to make a decision to go or no go. I would propose, based on your feedback, in three weeks to come to an end date. That decision can be that we accept that they can't pay at the moment.
- Dave Goss If nothing happens then I will invite Hoover Dam people to the meeting so that we know how to pursue.
- Chris Vasquez There's a lot of things that need to be discussed even if we do not get an answer in three weeks.
- Scott Mazick Does the number of busies equate to a system capacity?
- David Goss Yes, if for example if Henderson Fire has something going on and people are trying to get on the system, they might get a busy. We try to keep our capacity usage at about 30%.
- Brian Nebeker Is there a decrease when my department is off during the summer?
- Dave Goss Yes, the first day at school shows a huge difference in system usage.
- Frank Milligan Have we been going after any new accounts? I want to see that we are going after new business. And secondly, I think this should be a standing item.
- Dave Goss Yes, UNLV is one we are currently working with to join.

- Frank Milligan How are we working with Las Vegas Metropolitan Police Department? On terms of fees and things like that? I do not want us to be in competition with Las Vegas Metropolitan Police Department. I would like to see these items on this report and any discussions.
- Dave Goss Okay, sounds good.
- Jeff Buchanan Is your request for the Administrator's report to include new customers and ongoing discussions with Las Vegas Metropolitan Police Department?
- Frank Milligan Yes
- Jason Manzo Presented pictures of a map of the SNACC sites and where the new Panorama site is located. Nye County wanted the site because of dead spots caused by mountains. Adding the Panorama site reduced the dead spots they were having with their communications. Anyone on the SNACC system would be able to communicate in Pahrump.
- Jeff Buchanan I think this is very helpful to get these presentations. You showed there are some dead spots in the map for Nye County, are there any plans that this Board is going to have to address?
- Dave Goss They have some conventional and VHF coverage. If they want to go further north, we can discuss that with them.
- Jason Manzo Originally, Nye County had a VHF trunking system covering a large part of Nye County including Pahrump around 2008. After Nye County put in a VHF in Pahrump, they discovered the noise interference was so high, VHF did not meet Pahrump's needs. That is when we put an 800 site, the West site. Once they go outside of Pahrump they switch to VHF.
- Chris Vasquez This is similar to what we are doing now with Hoover Dam. Is there paperwork in place to sign the sites over to SNACC?
- Dave Goss Yes, we have a Memorandum of Understanding with them regarding the Panorama site. It is a little different than what we have going on with the Feds.
- 4. Discuss whether to change the equity buy-in fees for new or current SNACC members adding new radios to the system. (FOR DISCUSSION):
 - Dave Goss We voted before to do away with the buy-in fee, this is just to discuss whether we want to bring the buy-in fee back or not.
 - Jeff Buchanan Can we give a little
 - Frank Milligan
- 5. Approve Motorola change order #8 for two consoles, one AIS, one recorder, and the Panorama ASR site at Nye County. (FOR POSSIBE ACTION):
 - Dave Goss We are paying for the Panorama Site, everything else is being refunded. The change order is for \$58,129.50 we will be reimbursed \$45,306.50. SNACC will be paying \$12,823 (Non-reimbursable).
 - Chris Vasquez The change order#8 doesn't show SUAII charges, will there be additional charges for that?
 - Curtis Steadman We create Maintenance and bill in March. The SUAII will have no extra charge until eight months out. The approximation would be ongoing about \$12,000 to \$13,000. So maintenance plus the SUAII it will be about \$30,000/yearly.
 - A motion was made to approve; motion passed unanimously.

Administrator's Report

April 17, 2019

Technical Items:

On March 12th, 2019 the Microwave battery bank was replaced. The old batteries were 18 years old and were rated for 20 years. There was no downtime during the replacement.

We have begun the yearly PM at our sites. We have completed the following sites. Nye County West Site, Nye County Panorama, Potosi, Angles Peak, Geneva, Lake Las Vegas, RJC, Red Mountain, Boulder City Water Tank, Brooks, Spirit, and Oatman.

Moapa Tribal Police have been reporting poor radio communications. We went to their primary site Beacon and could not find any problems and our radios did not have problems. We tested a couple of their radios on our Aeroflex service monitor and found them out of tolerance. On March 14th they brought us 18 of their radios to place on the Aeroflex for realignment and the firmware for each radio was updated. Initial reports have indicated they believe radio communications have improved.

On February 21st at 2:41 AM there was a power outage at the SNACC office. Transfer Switch #1, which runs our 1st floor failed. Transfer Switch #2 which runs our 2nd floor was working. The only critical equipment on the 1st floor is the link for RTC dispatch. At approximately 4:00 AM the UPS for the RTC dispatch link depleted it power and the link went down causing RTC dispatch to use their backup in their console's until power was restored at approximately 6:00 AM. Clark County Automotive was notified of the problem with Transfer Switch #1. It was determined the internal battery in Transfer Switch #1 failed and was replaced and tested to ensure it was working. Also, we have changed out the UPS to a higher capacity UPS, which will hold the link for 6 hours in case of a generator problem in the future.

On March 21st Henderson Fire called to report bad radio communication at a house fire in the Inspirada area. We verified the system was not down or alarms indicating problems. Working with Fire Administration, HFD was able to determine the problem was only with one specific radio and not the radio system. HFD pulled the radio and brought it to SNACC so we could put on the Aeroflex service monitor and it was found to be out of tolerance. We were able to realign the radio and HFD put the radio back into service. We have followed up with Fire administration a couple of times now and no further issues are being reported with this radio. We will continue to work with Fire administration to ensure there are no other issues.

SNACC Business:

University of Las Vegas Nevada (UNLV) has cut a purchase order for approximately one hundred thirty five radios to add to the SNACC system, Mark Sakurada will be coordinating with us to schedule a date and get these units programmed.

Las Vegas Metropolitan Police Department and SNACC are continuing to interact with one another. LVMPD and SNACC communicate on a daily basis regarding radio subscriber updates. Recently, we have been assisting our users that interoperate with LVMPD with an IP address scheme change and rekey.
