 November 4, 2019

SNACC BUSINESS:

SNACC continues to have weekly meetings with Nye County on the upgrade of the VHF Radios.

SNACC is also continuing with weekly meetings on the UNLV Project. This also includes discussions on UNLV on adding additional department users on the SNACC system.

Provided information on talkgroup usage for the FAO Dispatch Center, to be provided to the Fitch Communication Center Assessment.

SNACC has programmed 476 Radios for 24 different agencies since the last SNACC meeting.

Harris Radio has been working with SNACC to approve the use of their product on our system.

SNACC personnel also attended a Motorola Trunked Users Group (MTUG) meeting. This meeting demonstrates new equipment and also has discussions on radio issues.

Dave Goss attended training on Conducting Investigations. This was required training by Clark County.

SNACC is continuing to work with Las Vegas Metropolitan Police Department on day to day radio update information of alias changes and approving new ID's for encryption for SNACC users as well LVMPD users.

TECHNICAL ITEMS:

We are continuing investigations into a microwave upgrade project. This is necessary due to the age of the equipment and the advancement in technology. (Analog operations to Ethernet operations).

Over Labor Day weekend the Lake Mead site went down. This ended up being an issue with LVVWD T1 connection to the site, LVVWD technicians corrected the problem.

SNACC and LVMPD have had some interference issues recently, causing channels to be interfered with. We have been working together along with Motorola to find the cause of the interference.

 Jason Manzo – In August, I had the opportunity to attend APCO and MTUG. APCO stands for Association of Public Safety Officials.

APCO was founded in 1935, APCO serves the government functions that provide public safety communications and other activities supported or endorsed by Federal, State, Local, and Tribal governments. APCO has helped built projects like Project 25, also known as P25. The classes that I took at APCO this year:

- 1. Protecting Public Safety Network from GPS and spoofing attacks
- 2. Cyber Security for Public Safety Communications
- 3. Providing Security and resiliency for Public Safety Radio System and IT Networks
- 4. How to write effect Standard Operating Procedures
- 5. How to manage a successful project.
- 6. Local Control for FirstNet Users
- 7. Federals Communications Commissions (FCC) Regulatory updates

MTUG stands for Motorola Trunking User Group. There are two types of radio systems:

Conventional Radio System: Use a specific radio frequency for a radio channel each time a radio is keyed up.

Trunked Radio Systems: Use several frequencies shared between all channels or talkgroups. This is for much larger and this is more efficient for large group of users.

MTUG is for radio users. MTUG brings together Motorola and the public safety and public service agencies that utilize the Motorola Trunked radio systems to promote development, sustainability, and education of Motorola products, services, and the mutual benefit of all parties.

One of the things that MTUG really does benefit system owners/users, is members from local MTUG chapters around the country work closely with Motorola help give input on products that are being designed and identify problems with current products and disseminate the solutions to all users. For example, one of the problems brought to our attention was a APX RS MIC – the mic was found to have fraying cords and it is mainly how law enforcement and fire personnel where their mics, on their shoulder or on their hip, this was causing excessive wear. Motorola extended the warranty. This was disseminated to all of our users. This is something that we might not have ran across unless we attend these meetings and get feedback from other states.

- Jeff Buchanan Thank you so much for the detail, this gives us a better understanding.
- Dave Goss There was interference with our channels. This effected LVMPD more than it affected SNACC.
- Chris Vasquez It is unknown what happened. The same thing happened a few days later.
- Jason Manzo It affected NLVPD (North Las Vegas Police Department) because APEX was hit and NLVP works more on that site than any other SNACC site.
- Chris Vasquez It took down a channel on the Simulcast or all the Simulcast
- Jason Manzo It took down one channel and that was Brooks, which NLVPD mainly uses.
- Jeff Buchanan It is critical for us to know what is going on and there is a current investigation going on with the FCC. Motorola, do you have any insight on this incident?
- Dustin Newsom we have the capability of locating RF interference and illegal carriers. It is just a matter of reaching out and asking for the help. We offered up and some of the agencies thought they had a handle on it so we backed off. This would be a team effort in conjunction with you or radio technicians and your radio experts, Motorola can help.
- Dave Goss From a technical aspect of this, we can't find the issue if it is not happening anymore.
- Chris Vasquez How did you find out there was an issue?
- Jason Manzo I was on call and no one notified SNACC. The day after the incident, LVMPD let us know via email.
- Jason Manzo there is certain criteria for us being notified. Because it only took down a few channels SNACC was not notified.
- Frank Milligan Is there a firewall that can be added to the system?
- Curtis Steadman If a site or dispatch center goes down for more than 5-10 minutes we would notify SNACC. We can make that tighter though, if you want to be notified there is interference for more than 10 seconds, we can make changes but you will be hit with a lot of notifications. If the interferences started again, we can put someone up on a site and track who or what is causing this interference. LVMPD did this for 24 hours and nothing happened during this particular incident. If it happens again, let us know and we can set up shop on a site and track it down.
- Dave Goss SNACC contacted AT&T and they said it was not them.
- Chris Vasquez AT&T sent out a letter giving us a heads up that they plan on adding some equipment.
- Dave Goss Yes, they said they will be contacting SNACC when this happens.
- Frank Milligan Is there anything that we can do now? Maybe add those sniffers now?
- Curtis Steadman When your agencies hear that there is new equipment being added by another vendor, let us know and we will add our sniffers and monitor between SNACC and LVMPD.
- Jeff Buchanan Would you be able to key in to the right individual from FirstNet and AT&T?
- Curtis Steadman Of course we can, I am sure we can.
- Jeff Buchanan What do you suggest to us, the Board, for us to do? What about the Cyber Threat side of things? Do we have the right security for this?
- Curtis Steadman We can get Dustin Newsom to speak on this.

- 3. Ratify the Administrator's execution of the Cooperative Management Agreement between United States Department of Interior, National Park Service and Southern Nevada Area Communications Council for radio console, hardware and software support, and other matters properly related thereto with the inclusion of Change 1, Change 2, and Change 3.
 - Tabled for the next SNACC meeting during agenda item#1.
- 4. Approve the Open Balances Procedures Policy. (FOR POSSIBLE ACTION):
 - Dave Goss This was a created to avoid having people be behind on their SNACC payments. We have had numerous agencies be past due for a few years.
 - Jeff Buchanan At what point would I be at risk to be disconnected?
 - Dave Goss 240 days.
 - Jeff Buchanan We wanted to make sure that this was a comfortable time frame for payments to be made.
 - A motion was made to approve; motion passed unanimously
- 5. Amending the System Compatible Radios Policy to have Group Services in the list of features. (FOR POSSIBLE ACTION):
 - Jason Manzo Group services helps programming be more efficient. Sometimes the radios need a
 firmware update, flashcode, and codeplug and this would be done at once over the air with this
 feature. This would avoid you having to come to our office or us going to your location and
 programming the radios manually. This capability would make it more efficient when it comes to
 programming.
 - Chris Vasquez Does this feature work for FDMA?
 - Jason Manzo I will find out, I think it would only work on TDMA.
 - Chris Vasquez This would help SNACC with man hours.
 - Jason Manzo Especially if it is a critical change that needs to be done in a timely manner. With group services the computer does all the programming in a few days verses weeks/months of manually programming. If you purchase with the radio it is \$109 after NASPO pricing. After purchase it is \$126/per radio after NASPO pricing.
 - A motion was made to approve; motion passed unanimously
- 6. Approve Purchase Order for the Bureau of Reclamation (BOR) to add an ASR (Astro Site Repeater) site at Hoover Dam. (FOR POSSIBLE ACTION):
 - Dave Goss The BOR has offered to pay us for the site being placed there. This was originally going to be a joint effort between SNACC, National Park Service, and BOR.
 - Chris Vasquez The funds are for the accessing the site?
 - Jason Manzo Yes, to have site access.
 - Jeff Buchanan There is no liability on Clark County?
 - Wendy Lotman The concern was that Clark County would be liable, but no this is SNACC's project, they are liable.
 - Chris Vasquez During this project, there has to be a SNACC representative on site during this entire project until completion per the contract.
 - A motion was made to approve; motion passed unanimously

- 7. Approve the Motorola Change Order 9 to include Hoover Dam ASR (Astro Site Repeater) Site and Complimentary Basic Cyber Security Risk Assessment. (FOR POSSIBLE ACTION):
 - Dave Goss Motorola will be the ones installing the site at Hoover Dam and they added in a complimentary cyber security risk assessment.
 - Dustin Newsom this will be an assessment of the radio network. This is all IP based, this has vulnerability to ransom ware and malware, this is becoming more evident across the country. A couple of the radio sites, dispatch sites will be assessed. If you want the full assessments that will all be included with Premier Services. We figured this was a good idea to give a taste of what this assessment might look like.
 - Jeff Buchanan does this evaluation also include the capacity of the system? A complete analysis?
 - Dustin Newsom it will be a smaller version of that and then we can move forward to the complete analysis if you all feel it necessary.
 - Chris Vasquez the complete analysis would include if the sites are all full capacity? How long will it take?
 - Dustin Newsom we will aim for January. It will take 3-4 weeks to get the reports. Premier services would include a system manager, like Rory Nesland for LVMPD. This person would be involved hands on with any technical issues with the system. He runs system upgrades.
 - A motion was made to approve; motion passed unanimously

Background:

On August 28, 2019 the Board made a motion to bring this item back to the Board for final approval of keeping the National Park Service on the SNACC system, if payment was received. The National Park Service paid SNACC \$107,972.40 on September 11, 2019 for the one-time charges covering computer and radio hardware that support NPS operations, per Cooperative Management Agreement between SNACC and National Park Service. On September 23, 2019 the SNACC Board had an emergency meeting to ratify the Cooperative Management Agreement which signed by the SNACC Administrator. There were some changes that needed to be made on Page 1 under 'Statement of Work' to the Change 1 document. The Board tabled the agenda item for the next SNACC Board meeting on October 16, 2019. Change 2 was also received, however, did not include specific radio count for security radios to be programmed. The SNACC Administrator reached out to NPS for additional change, Change 3 to reflect the count of security radios and to state "Payment due 30 days within the invoice issuance".

THIS COOPERATIVE MANAGEMENT AGREEMENT is made and entered into by and between the Southern Nevada Area Communications Council (SNACC), and the UNITED STATES OF AMERICA, acting through the National Park Service (NPS). Throughout this agreement, both the NPS and the SNACC may be jointly referred to as the "Parties."

ARTICLE I - BACKGROUND AND OBJECTIVES

The objective of this Cooperative Management Agreement is to allow the NPS to be part of the SNACC, specifically allowing the shared use of radio communication, equipment, and services in support of the public safety.

ARTICLE II - AUTHORITY

- A. NPS enters into this Cooperative Agreement pursuant to the following authorities:
 - 1. 54 U.S.C. §101703 (a and b) The Secretary of the Interior is authorized to enter into an agreement with a State to provide for the cooperative management of the Federal and State park areas where a System unit is located adjacent to or near a State park area, and cooperative management between the NPS and a State will allow for more effective and efficient management of the System unit and State, provided that the Secretary does not transfer administration responsibilities for any System unit. Under a cooperative management agreement, the Secretary may acquire from and provide to a State agency goods and services to be used by the Secretary and the State in the cooperative management of land.
 - 54 U.S. Code § 101702 (d) The Secretary may enter into cooperative agreements with State, local, or tribal governments, other Federal agencies, other public entities, educational institutions, private nonprofit organizations, or participating private landowners for the purpose of protecting natural resources of System units through collaborative efforts on land inside and outside the System units.
 - 54 U.S.C. §§ 102701-102712. the NPS is authorized to render emergency rescue, firefighting, and cooperative assistance to nearby law enforcement and fire prevention agencies and for related purposes outside of the National Park System. Additionally, the Secretary of the Interior is authorized to designate officers and employees of any other

federal agency or law enforcement personnel of any state or political subdivision thereof, when deemed economical and in the public interest, and with the concurrence of that agency or that state or subdivision, to act as special police officers in areas of the National Park System when supplemental law enforcement personnel may be needed, and to exercise the powers and authorities delegated to NPS Rangers and US Park Police Officers.

B. SNACC enters into this agreement pursuant to:

1. Nevada Revised Statues Chapter 277 or Joint Powers Agreement (JPA). NRS 277.180 – Interlocal Contracts.

ARTICLE III -- STATEMENT OF WORK

A. Background:

Lake Mead Interagency Communications Center (LMICC) manages emergency communications, public safety dispatching and is secondary public safety answering point for all federal land management agencies in Southern NV. This includes; four(4) NPS sites (Lake Mead NRA, Grand Canyon Parashant NM, Tule Springs Fossil Beds NM, and Great Basin NP), BLM law enforcement across the entire state of Nevada, USFS (Humboldt-Toiyabe NF), Bureau of Reclamation (Hoover Dam and other BOR lands within the Lower Colorado Region) and USFWS Desert Refuge Complex. This vast amount of land also hosts a large amount of visitation, use, crime and emergencies. It is located within and surrounding the Las Vegas Valley. These factors make for a wide variety of local, state and federal partners to provide law enforcement and emergency response. Each agency has a variety of frequencies across a varied spectrum. The need to communicate with each or multiple simultaneously is paramount for an appropriate and effective provision of public safety services. The local and county agencies coordinate through the Southern NV Area Communication Council. This entity manages radio frequencies for each agency as well as shared frequencies designated for multi-agency responses. The radio system is a proprietary network of towers, repeaters and associated computer components that must function together and must integrate into the radio consoles at the LMICC. Due system security needs, SNACC maintains the system and manages the system components. There is no other vendor that is able to provide the interoperability. The LMICC cannot procure the system components and build a link to interface due to encryption programming.

B. SNACC will provide the following:

- Direct access to the 800 MHz Public Service Radio System and indirect access to the 700 MHz Law Enforcement Radio System. Access provides interoperability with Local, State, and Federal Public Service and Law Enforcement Agencies
- Program National Park Service dual-band radios with partner agency and interoperable frequencies managed by SNACC, as defined in radio frequency agreements
- Manage Software User Agreement (SUA) and a hardware maintenance agreement for the LMICC dispatch console components
- Provide Radio console (Motorola MCC7500) radio console software and hardware support, which includes, software and hardware updates, patches, diagnostics, troubleshooting and repair of radio issues

 SNACC Technicians will submit the personally identifiable information required by National Park Service to complete a thorough background check (signed releases and fingerprint cards)

ARTICLE IV - TERM OF AGREEMENT

This Agreement shall become effective on 08/28/2019 through 08/27/2024, unless prior thereto it is terminated pursuant to the provisions of Article VIII hereof or of any applicable Federal or State law or regulation.

- B. Communications. The Parties shall address any communication regarding this Agreement to the key officials.

C. Changes in Key Officials. The Parties may make not any permanent change in a key official without written notice to the other party.

ARTICLE VI - EXPENDITURE OF FUNDS

- A. Funding: The NPS will provide funding to the Clark County Information Tech Dept.; Attn: Accounts Receivable, 500 South Grand Central Pkwy. Box 551700, Las Vegas, NV 89155-1700 in an amount not to exceed \$21,594.48 per year for the work described in Article III and in accordance with the approved budget. In addition to the \$21,594.48, NPS agrees to pay a one-time payment of \$107,972.40 for computer and radio hardware that support NPS operations. Any award beyond the current fiscal year is subject to availability of funds.
- B. SNACC shall request payment in accordance with the following:
 - 1. Method of Payment: Reimbursement through electronic fund transfer.
 - 2. Requesting Reimbursement: Requests for reimbursements must be submitted via mail or email see addresses below. Invoices should not be submitted more than once monthly. Requests for reimbursement should coincide with normal billing patterns. Each request must be limited to the amount of disbursements made for the Federal share of direct project costs and the proportionate share of allowable indirect costs incurred during that billing period.

ARTICLE VII - PROPERTY UTILIZATION AND DISPOSITION

Any tools, equipment, material or other property supplied by an agency shall remain its own. Each agency agrees to properly maintain and safeguard each other's property. Reimbursement or replacement for loss or damage to the other agency's property shall be handled in accordance with the responsible employee's agency policy.

ARTICLE VIII - MODIFICATION AND TERMINATION

A. This Agreement represents the entire understanding of the Parties. No prior oral or written understanding shall be of any force or effect with respect to those matters specifically covered in this Agreement. This Agreement may be modified only in writing executed by the Parties.

B. Either party may terminate its participation in this Agreement by providing sixty days written notice to the other party.

ARTICLE IX -GENERAL AND SPECIAL PROVISIONS

A. Non-Discrimination

All activities pursuant this Agreement shall be in compliance with the requirements of Executive Order 11246; Title VI of the Civil Rights Act of 1964, as amended, (78 Stat. 252; 42 U.S.C. §§ 2000d et seq.); Title V. Section 504 of the Rehabilitation Act of 1973, as amended, (87 Stat. 394; 29 U.S.C. §794); the Age Discrimination Act of 1975 (89 Stat. 728; 42 U.S.C. §§ 6101 et seq.); and with all other federal laws and regulations prohibiting discrimination on grounds of race, color, sexual orientation, national origin, disabilities, religion, age, or sex.

B. Lobbying Prohibition

18 U.S.C. § 1913, Lobbying with Appropriated Moneys - No part of the money appropriated by any enactment of Congress shall, in the absence of express authorization by Congress, be used directly or indirectly to pay for any personal service, advertisement, telegram, telephone, letter, printed or written matter, or other device, intended or designed to influence in any manner a Member of Congress, to favor or oppose, by vote or otherwise, any legislation or appropriation by Congress, whether before or after the introduction of any bill or resolution proposing such legislation or appropriation; but this shall not prevent officers or employees of the United States or of its departments or agencies from communicating to Members of Congress on the request of any Member or to Congress, through the proper official channels, requests for legislation or appropriations which they deem necessary for the efficient conduct of the public business.

C. Anti-Deficiency Act

31 U.S.C. § 1341 - Nothing contained in this Agreement shall be construed as binding the NPS to expend in any one fiscal year any sum in excess of appropriations made by Congress for the purposes of this Agreement for that fiscal year, or other obligation for the further expenditure of money in excess of such appropriations.

- D. Prohibition on Text Messaging and Using Electronic Equipment Supplied by the NPS While Driving Executive Order 13513, Federal Leadership on Reducing Text Messaging While Driving was signed by President Barack Obama on October 1, 2009 (ref.:http://edocket.access.gpo.gov/2009/pdf/E9-24203.pdf). This Executive Order introduces a Federal Government-wide prohibition on the use of text messaging while driving on official business or while using Government-supplied equipment. Additional guidance enforcing the ban will be issued at a later date. In the meantime, please adopt and enforce policies that immediately ban text messaging while driving company owned or rented vehicles, government-owned or leased vehicles, or while driving privately owned vehicles when on government business or when performing any work for or on behalf of the federal government.
- E. Employees, Consultant, Agents, Contractors and Subcontractors

- Either party may engage consultants or contract administration personnel as subcontractors to perform, administer, or coordinate any task governed by this Agreement and the attachments hereto. Nothing in this Agreement shall be construed as preventing either party from utilizing as many employees as deemed necessary for the proper and efficient execution of this Agreement.
- 2. All third-party contracts and or subcontracts executed in furtherance of this Agreement shall follow any and all Federal or State laws regarding contracting.

F. Liability

- The United States shall be liable, to the extent allowed by law, including the Federal Tort Claims Act, for claims for personal injuries or property damage resulting from the negligent or wrongful act or omission of any employee of the United States while acting within the scope of his or her employment, arising out of this Agreement.
- 2. The Southern Nevada Area Communications Council shall be liable, to the extent allowed by law, including the Federal Tort Claims Act, for claims for personal injuries or property damage resulting from the negligent or wrongful act or omission of any employee of the Southern Nevada Area Communications Council while acting within the scope of his or her employment, arising out of this Agreement.

G. Severability

If any one or more of the terms, provisions, promises, covenants or conditions of this Agreement shall to any extent be adjudged invalid, unenforceable, void or voidable, for any reason whatsoever by a court of competent jurisdiction, each and all of the remaining terms, provisions, covenants, promises, and conditions of this Agreement shall not be affected thereby and shall be valid and enforceable to the fullest extent permitted by law.

H. Disputes

- 1. This Agreement shall be construed and interpreted, as to both validity and performance of the Parties, in accordance with the laws of the United States.
- 2. In the event of any dispute arising under this Agreement, the injured party shall notify the injuring party in writing of its contentions by submitting a claim therefore.

ARTICLE X - ATTACHMENTS

If there are attachments, they are incorporated into this Agreement. In the event of any apparent conflict between the terms of the Agreement and the attachments, the terms of the Agreement, including its designations and modifications, will prevail.

- SNACC Technicians will submit the personally identifiable information required by National Park Service to complete a thorough background check (signed releases and fingerprint cards)
- 35 Security Radios at Hoover Dam will be programed with interop channels for communications with outside agencies.
- SUA payment is due 30 days within the invoice issuance.
- Any additional consoles will have an SUA cost of \$1799.50

Nye County will be joining all of the other SNACC users with Dispatch Centers covered by SNACC's Console maintenance and SUA II contract with Motorola beginning March 1, 2020.

MEMORANDUM OF UNDERSTANDING

This Agreement is made by the County of Nye, a political subdivision of the state of Nevada (herein after called "County"), and the Southern Nevada Area communications council (Herein after called "SNACC").

WHEREAS, the County and SNACC maintain and operate communication facilities at locations within Clark County and Nye County, and;

WHEREAS, the parties desire to expand their coverage to enable their users to communicate to areas outside of their current limits to establish a regional concept of communications systems, and;

WHEREAS, the intended mutual benefits for this agreement are; Homeland Security and Urban Area Security Initiative Issues, Communication System(s) interoperability, acquiring federal grants, sharing of resources, regional planning, and connection to one of the Nevada Homeland Security Designated "NCORE Systems," and;

WHEREAS, the parties maintain their communications systems for the purpose of enhancing public safety and desire to improve their ability to do so and therefore mutually agree as follows:

- 1. SNACC hereby agrees to allow County to connect to the SNACC Smart Zone Switch located at the SNACC Headquarters. The connection will be achieved via the Clark County Microwave System. The connectivity and quality of the connection will be Nye County's responsibility. SNACC makes no warranty regarding connectivity. Nye County will add the necessary infrastructure equipment to augment the SNACC Smart Zone Switch to accommodate the capacity that Nye County will need for communications support. All additional equipment added to the SNACC Smart Zone Switch will be maintained by SNACC and the cost(s) of this maintenance will be passed onto Nye County through the SNACC/Motorola Service Agreement. Costs associated for connection to the SNACC Smart Zone Switch (Fiber Modem, T1 Jack Fields, fiber optic connections) will be incurred by Nye County.
- 2. County hereby grants authority to SNACC to install, maintain, and operate its communications equipment on the sites specified in Exhibit A which is attached to this memorandum. SNACC is hereby authorized to access the sites whenever necessary for installation, repair or maintenance. Nye County will provide site space for SNACC's 800 MHz infrastructure at Nye County Sites at no cost to SNACC. SNACC will be responsible for maintaining all of SNACC's associated equipment.

- 3. This Agreement will be effective for a term of seven (7) years upon approval by both parties. The Agreement may be extended or renewed by mutual consent of both parties.
- 4. This Agreement may be terminated for any reason by either party by providing written notice to the other party at least ninety (90) days prior to the termination. During the ninety (90) day period, the parties may negotiate for further extensions of time if the requested by one of the parties.
- 5. The parties may add or delete sites from Exhibit A by mutual consent of the parties.
- 6. The party installing equipment or software in the other party's site must ensure that such installation and operation will not interfere with the quality of the reception or transmission of the other party's equipment. Should any such interference develop, the installing party will correct the situation at its own expense and to the specifications set by the other party. Security Partitioning will be used on the SNACC system to separate the Nye County VHF users from the SNACC 800 MHz users.
- 7. The parties do not waive and do intend to assert all available liability limitations including those granted by Chapter 41 of the Nevada Revised Statutes.
- 8. Nothing contained in this Agreement shall be deemed or construed to create a partnership or joint venture, to create relationships of an employer/employee or principal/agent, or to otherwise create any liability whatsoever upon one party with respect to the indebtedness, liability or obligation of the other party.
- 9. All the property presently owned by the parties shall remain the sole property of the entity that now owns it upon the termination of the Agreement.
- 10. The parties understand that both parties must comply with the public Records Law and that records retained by the parties will be considered public records unless made confidential by statute or a common law balancing test. Each party agrees to keep confidential all information received by that party to the extent that such information is made confidential or privileged by statute or common law balancing test.
- 11. This Agreement and the rights and obligations of the parties shall be governed by the laws of the State of Nevada.
- 12. It is specifically agreed between the parties executing this Agreement that this Memorandum is not intended to create in the public or any individual a status of third party beneficiary or to authorize anyone not a party to this Agreement to maintain a suit for personal injuries or property damage against either of the parties.

- 13. Maintaining Federal Communications Commission (FCC) licensing at all Nye County communications sites will be maintained by Nye County and copies must be made available for SNACC's files.
- 14. Nye County will maintain software upgrades at Nye County sites to be consistent with SNACC System software levels. Nye County shall pay SNACC Seventeen Thousand Nine Hundred Ninety Five Dollars and Forty Cents (\$17,995.40) annually over a seven (7) year period (2020-2026) beginning fiscal year 2021 (November 2020). This will include all software and hardware upgrades to the Dispatch Consoles necessary to keep the system current. The individual SUA cost for each console is One Thousand Seven Hundred Ninety Nine Dollars and Fifty Four Cents (\$1799.54) annually for the duration of the seven (7) year period. Any future consoles/AIU's (Audio Interface Unit) added by Nye County will be billed at the rate of One Thousand Seven Hundred Ninety Nine Dollars and Fifty Four Cents (\$1799.54) annually per console position.
- Nye County will maintain continuity with the NPSCC Executive order 2014-01 and SNACC's plan to migrate to an APCO Project 25 digital platform.
- Nye County will provide copies of any and all MOUs for connection to the Microwave System Carriers that will be used.
- 17. Nye County shall pay SNACC the annual Console Maintenance Twelve Thousand Eight Hundred Sixty Dollars (\$12,860) for the first year for Nye County's Dispatch Center with an escalation of three percent each year, for the next eight (8) years (2020-2027) beginning fiscal year 2020 (March 2020). This will include four MCC7500 Consoles in Pahrump, two MCC7500 in Beatty, two AIU's located in Pahrump, and two MCC7100 consoles. The individual maintenance cost for each console is One Thousand Two Hundred Eighty Six dollars (\$1286.00) for the first year. Any future consoles/AUI's added will be billed at the rate of One Thousand Two Hundred Eighty-Six dollars (\$1286.00) for the first year and will include an escalation rate of three (3) percentage annually for subsequent years.



- Proposed Future Capital Projects ~
 - Microwave Upgrade: The SNACC microwave system must be upgraded to Ethernet operations to maintain compatibility with the radio system as further technological advancements are implemented. Year 1 of 3 is expected to be started in fiscal year 2020.
 - Vehicle Replacement: Technician's vehicle will be 13 years old and will require replacement due to high mileage and increased repair expense.
 - GPS (Global Positioning System): Enables dispatch centers to precisely pinpoint the location of a transmitting radio in order to have emergency services respond to that exact location.
 - TDMA Migration: This technology effectively doubles system capacity and enables more efficient communication with newer systems such as those in use at LVMPD and State of Nevada.
 - OTAP (Over the Air Programming): Newer APX radios could be programmed "over the air," thereby eliminating the need to deliver radios to SNACC offices for programming.
 - Radio Management: This allows for firmware upgrades and is used in conjunction with OTAP. This also automatically tracks codeplug data for each radio on the system.
 - Astro Standalone Repeater (ASR) Site: This site will be built at an as-of-yet undetermined site, depending on where there is growth in the valley.
